

**Declaration to the EU regulation (EC) No. 1907/2006** of the European Parliament and the Council of 18 December 2006 concerning the **Registration, Evaluation, Authorization and Restriction of chemicals (REACH)** published on the 30<sup>th</sup> of December 2006 in the EC-Official Journal 396/1.

IDS Imaging Development Systems GmbH is the manufacturer of products within the meanings of REACH and is classed as a "downstream operator". Therefore in principle, IDS Imaging Development Systems GmbH comes under no registration requirements according to REACH directive (EG)1907/2006. This is especially true because no chemical materials can be released from our products under standard or reasonably foreseeable conditions of use (see Sect. 7 Para. 1 of the REACH-Regulation).

We constantly seek information as to whether the listed materials that require special care are contained at more than 0.1% by volume in the materials, preparations, or products we use. With the exception of the product groups mentioned **in Annex 1**, there are no further indications at the moment that our products contain substances of concern above the limit values. If and to the extent that SVHC should be contained in our articles, we will meet our obligations in accordance with REACH, including the obligation to provide information to our customers. This also applies for future changes in the candidate list.

The supplied articles do not contain any substance on its own, in a mixture or in an article which is included in REACH Annex XIV (Authorisation list) or which REACH Annex XVII contains a restriction.

We create and submit the required SCIP notifications to ECHA for products subject to notification. Please refer to **Annex 1** for the corresponding SCIP numbers.

#### UK REACH

The UK has implemented this EU Regulation almost as is in its on Regulatory framework. All necessary information regarding our requirement to provide information in accordance with Article 33 can be found **in Annex 1**.

**We will update this statement and the corresponding SCIP-notifications as soon as a change of the EU REACH/ UK REACH-requirements makes this necessary.**
